## Board of Trustees of Morley Library

April 20, 2022

A regular meeting of the Board of Trustees of Morley Library via teleconference was called to order at 4:35 P.M. on April 20, 2022 by Mr. Keener. The following members were present:

The minutes of the March 16, 2022 regular Board Meeting were reviewed. Mr. Di Iorio moved that the minutes be approved as submitted, Ms. Severa seconded, and the motion carried unanimously.

Ms. Norman reviewed the April Treasurer's Report. Ms. Coffee moved that the report be accepted, Mr. Di Iorio seconded, and the motion passed unanimously.

Ms. Norman announced the results of discussions with department managers regarding staffing levels; because of those needs, retirements, and resignations the library will be hiring 2 full-time and 6 part-time employees. Those positions have been posted and applications are being received. Ms. Norman reported an interview with a former employee who declined to accept an employment offer due to salary level. Competitiveness of staff compensation was discussed, but no firm conclusions were reached.

Director Martinez reported that masking for Staff had been made optional and that the library's circulation statistics were improving. She reiterated that operating hours could not be expanded until additional staff was in place.

Ms. Norman reported that a new staff parking contract had been received from the Masonic Lodge, and that Mr. Gorom had vetted it and suggested changes, primarily to the duty of the lessor to keep the lot in good condition during the winter months. She has returned the contract and requested that the changes be made, but has not yet received a response.

Ms, Lipps moved adoption of the following resolution:

RESOLVED, that Ms. Fedor will be paid 25% of her accumulated sick leave, not to exceed \$5500.00.

Ms. Severa seconded and the motion carried unanimously.
